

T.O.S. fursuit adoptable Creation'Ator

Before any purchase from me, please read the TOS carefully to be aware of the following conditions :

If you make a purchase, you agree to the TOS listed below.

Sorry if there are any mistakes in english, i try my best !

1) Fursuit :

- The sold fursuit will be made entirely by myself. (except in very rare cases where the base will not be from my home, but if that happens, the maker of the base will be credited)
- I'm still discovering some techniques that require patience and practice. The quality supplied is the best I can produce. Please don't compare the quality of my work to that of another fursuit maker. Everyone advances at their own pace, each fursuit maker is unique.
- The faux fur will be of Luxury quality.
- Please know that my price is evaluated on my quality, don't buy from me for my price. If I'm cheaper or more expensive than other fursuit makers, you should know that my price is evaluated only on the basis of my experience, it will increase with the experience acquired over time.
- If you want to resell the fursuit as it is (without major modifications made to it) you can't sell it for more than it cost you.

2) The character :

- The character design will be created by myself (or in collaboration with artists) based on the parts made.
- You can change the design as you see fit. But let me know if you change it. I will not be responsible in any way for the differences between the design of the fursuit and the new design you will have created afterwards.
- Body parts not designed / created by me, you can create them as you see fit.

3) Payment :

- Payment is made in 1 to 2 times maximum. If payment in one go, the fursuit will be sent to you after payment received well. If payment in 2 installments, the fursuit will be sent to you once the 2nd payment has been received.
- If the price exceeds 1200€, you can pay in 3 installments.
- The payment in 2 or 3 times will be made a first time of a non-refundable deposit of 50% to reserve the continuation. For subsequent payments, you have an interval of 30 days between each of them, following receipt of the non-refundable deposit. If payments aren't sent correctly, I reserve the right to relist the fursuit.
- As long as no payment is received from you, the fursuit is not yours. It's first come first serve.
- REFUND : no refund is possible. Once the purchase is made, there is no going back. Be sure of yourself before you buy. If you cancel the purchase in full payment, nothing will be refunded.
- Payment can be made via Paypal or bank transfer (the costs incurred by Paypal and by bank transfer will be at your expense)
- PRICE NEGOTIATION : any insistent price negotiation requests will be penalized with a refusal to purchase your by definitively from the one you are making.

5) Shipments / deliveries :

- It will be sent by Mondial Relay, by post or by hand. All costs will be at your expense.
- The fursuit will be sent to you within 2-10 business days of receipt of the very last payment.
- Once deposited, I am not responsible for any delays or damage to the package and / or the fursuit..
- Upon receipt of the fursuit, it will be entirely yours, you do what you want with it. Furthermore, I don't vouch for any modifications made to your fursuit by anyone other than myself.

6) Besoin d'une réparation / modification ?

Need a repair / modification of a part of the fursuit? (only those made by me)

You can contact me when opening orders, the price will be evaluated after discussion on the repair / modification to be made.

If after 30 days of our discussion I have not received the fursuit, I consider that it no longer needs to be repaired / modified.

If after purchase you wish to change the character design, I am in no way responsible for the differences between the new design and the design of the made fursuit.
